PROJECT DESCRIPTION:

The project consists of approximately 40 linear feet of 8" ductile iron gravity sewer, 1 manholes; 13,855 lf of 6" PVC force main, 20 lf of 6" ductile iron force main, ductile iron pipe fittings, 290 lf of directionally drilled 6" HDPE force main, 280 lf of 6" ductile iron force main in 12" steel encasement bore, 4 air release valves, one (1) 180 gpm duplex submersible pump station with valve vault and flow meter vault, 4" sewer force main yard piping, a water service connection, access road, emergency standby generator, electrical work, asphalt driveway and road patching and resurfacing, concrete sidewalk replacement, connection of force main to existing sanitary sewer manhole, erosion control and miscellaneous valves and appurtenances.

FUNDING: This project is being funded through the State Revolving Fund administered by the South Carolina Department of Health and Environmental Control. The successful bidder will be required to meet the requirements of SRF Guidelines and Appendix A, Mandatory Supplemental General Conditions For the South Carolina State Revolving Fund Program, June 2012, a copy of which is available at SCDHEC website and is provided in the bid documents for this project. Requirements for this project include compliance with the Davis-Bacon Act, pre-approval of subcontractors (if any are used) and contractor completing Six (6) Good Faith Efforts to recruit Disadvantaged Business Enterprises (DBE's) firms for subcontract work (if any).
