CHILDREN'S PET SHOW GUIDELINES

1. All participants must be twelve or under to participate in the pet show.
2. All pets **MUST** be leashed or caged and controlled at all times. All pet owners will be responsible for the actions of their pets.
3. Owners **MUST** provide a current (vaccinated within the past year) rabies vaccination certificate for dogs, cats, and ferrets. Vaccinations must be administered by a licensed veterinarian and certificate issued by same.
4. A parent or guardian and a child **MUST** sign the registration form to enable the child to participate.
5. An owner can enter up to two pets, but the two pets entered must be in different classes.
6. Trophies will be awarded for first through sixth place winners for the general classes. A larger trophy will be awarded to the winner of the Best of Show class.
7. Judges have the right to refuse any entry.
