Request of Major Site Plan Approval for a +/- 3,500 sq. ft. Convenience Store and Gas Station with 24 fueling points.

2. SUBDIVISION

[SD-14-01 \(Rev 2\) Ellerbe Estates \(County\)](#)

A request for preliminary plat approval to revise the layout of the Ellerbe Estates Subdivision Phase 2, and to rename a portion of the Subdivision “Depass Heights”.

A request for preliminary plat approval to add a total of 21 additional lots to Phase 2 of Bradford Meadows.

4. ORDINANCE AMENDMENT

OA-22-01, Gasoline and Alternative Fuel Service Stations and Truck Fueling as Conditional Uses, and Updates to Commercial Site Circulation Regulations (City)

Amend Article 3, Sections g, h, i, j, k, and l to permit gasoline and alternative fuel service stations, with or without convenience stores, classified under SIC Code 5541 as a conditional use, to amend Article 3, Sections i, k, and l to permit truck stops classified under SIC Code 5541 as a Conditional Use, to amend Article 10 to include a definition for truck stops, gasoline and alternative fuel service stations, and Gasoline and alternative fuel service stations with convenience stores, and to adopt standards under Article 8.b.4 for commercial and industrial site design.
