Thank you for your interest in showing and selling your plants and/or gardening related products at the Iris Festival’s “Art in the Gardens.” This outdoor event will be held in the Bland Gardens, on the north side of the famous Swan Lake Iris Gardens in the heart of Sumter. We are happy to offer a three-day event, which will begin on Friday, May 28 and conclude on Sunday, May 30, 2021.

The fee for this event is **\$80.00** for each 10’ x 10’ green spot, or **\$150.00** for a 10’ x 20’ double spot. Each vendor must possess a business license from the City of Sumter. To obtain this license (fee is an additional **\$5.00**), please contact the City of Sumter Business License Office at PO Box 1449, Sumter SC 29151-1449 or call (803) 774-1601.

Listed below are the Policies:

1. NO FOOD OR BEVERAGES MAY BE SOLD OR GIVEN AWAY.
2. MOBILE CAMPERS AND RVS ARE PROHIBITED IN THE PARK AND FESTIVAL PARING AREAS.
3. **SETUP TIME WILL BE 1:00 – 3:00 on Thursday, May 27.**
4. SHOW HOURS ARE FROM FRIDAY-SUNDAY 10:00-6:00.
5. ALL VENDORS ARE TO PROVIDE FOR THEIR OWN NEEDS (i.e., tables, tents, etc.)
6. NO ELECTRICAL ACCESS IS AVAILABLE.
7. VENDORS MUST HAVE A CITY OF SUMTER BUSINESS LICENSE.
8. APPLICANT HEREBY INDEMNIFIES THE IRIS FESTIVAL COMMISSION, THE CITY AND COUNTY OF SUMTER, SUBSIDIARIES AND AFFILIATES IN THE EVENT OF LOSS OR DAMAGE TO GOODS AND/OR PERSONAL INJURY.
9. THE IRIS FESTIVAL COMMISSION RESERVES THE RIGHT TO REFUSE ENTRY TO ANY VENDOR.
