- Performer(s) must perform at all agreed-upon dates and times.
- Up to two 24x36 signs may be displayed with your name or logo in front of the stage (performer provided).
- No flyers may be distributed onsite *unless requested and approved by the Iris Festival Marketing Committee no later than Monday, May 4.*
- Performers are responsible for loading and unloading their own equipment.
- Sound is provided by the Iris Festival and monitored by the sound crew.
- No profanity or obscenity will be tolerated.
- Performance and all music must be family-friendly.
- Any background music must be provided to the Iris Festival Contact below by Monday, May 11th. Wi-Fi is not available.
- Performer(s) must check in with the sound crew at least 15 minutes before the performance.
- The Committee reserves the right to refuse entry to any performer(s).
- Absolutely NO parking will be available by the stage; please bring adequate setup and/or break-down equipment and pull/push roll carts as needed. Additional assistance may be available; however, all coordination with Iris Festival or Visitors Center staff must be planned by Monday, May 11th.

Performer(s) hereby indemnify the Iris Festival Commission, the City of Sumter, Sumter County, the Entertainment Committee, Iris Festival Committee, and their members, subsidiaries, and affiliates in the event of loss or damage to goods, music, CDs, tapes, equipment, and/or personal injury. Undersigned also understands and agrees to abide by all rules of the event.
