Listed below are the Policies:

1. No food or beverages may be sold.
2. Mobile campers are prohibited in the park.
3. Setup time will be **7 a.m. Saturday, April 4, 2020**. Setup **must** be completed no **later than 7:45 a.m.**
4. Show hours are 8 a.m. until 12.
5. All participants are to provide for their own needs (i.e. tables, tents, etc.). For special requests, please call Lynn Kennedy at (803) 774-1659. **Special arrangements must be made in advance of the event.**
6. Electrical access is available (110v only).
7. You must have a City of Sumter Business License if you are selling.
8. Applicant hereby indemnifies the City of Sumter and its subsidiaries and affiliates in the event of loss or damage to goods and personal injury.
9. The City reserves the right to refuse any application.
10. All items must be "green" with respect to sustainability, renewability and/or environmental concerns.
