

II. BACKGROUND

This request is to rezone 2 parcels totaling +/-2.2 acres (herein referred to as the property) from Agricultural Conservation (AC) to Heavy Industrial (HI). The applicant, Raymond Smith, purchased the property in June of 2020 with the intent of developing a car stereo retail sales and installation use on the site. The applicant submitted a rezoning request in 2020 (RZ-20-10) to reclassify the zone from AC to General Commercial (GC). That request was denied on second reading by County Council on September 22, 2020.



The subject parcels are located on the south side of S. Guignard Pkwy. (US-521 South) near its intersection with Jimmie St. and Rainaire Blvd., as shown on the location map on the first page of this report.

The subject parcels are part of what was originally a 30 acre tract created by division of the estate of Eddie Martin in 1953 (PB Z11, Pg 137). That tract was then further divided as a 16-lot residential subdivision known as the "Martin Subdivision" via multiple plats in the 1970s. TMS #225-00-03-010 was created in 1990 as a 0.46 acre lot, while TMS #225-00-03-035 is the remainder of the 30-acre tract.

This section of S. Guignard Pkwy. was widened to 5 lanes in the mid-2000s in part to provide a more efficient connection between Manning Rd. and US Hwy 15 South and to promote development of key industrial sites in the general vicinity. Current land use in close proximity to the property primarily consists of single-family residential uses on larger lots, vacant land, and religious institutional uses. Adjacent land to the north is zoned Heavy Industrial (HI). There are existing industrial uses to the northwest of the property that are set back several hundred feet from the S. Guignard Pkwy. right-of-way.




Above: Site Picture (captured from Google Streetview March 2025)

Zoning

As shown in the zoning map to the right, the site is currently in the AC zoning district and is adjacent to AC zoning to the east, west, and south. Adjacent land to the north, on the opposite side of S. Guignard Pkwy., is zoned HI.

The AC zoning district is designed to protect and preserve areas of the county which are presently rural or agricultural in character and use. AC parcels are required to be at least 1.0 acre in size, and primarily permit single family residential and agricultural uses, with select nonresidential uses permitted with additional conditional and special exception use review.



The intent of the HI district is to concentrate heavy industrial uses in areas where they will flourish without adversely affecting adjacent less intensive uses, and to preserve prime industrial lands for future industrial development. Residential development is not permitted in the HI district, nor is the establishment of HI zoning on other than a major road or highway.

The proposed use of the site falls under North American Industry Classification System Code (NAICS) 334 – Computer and Electronic Product Manufacturing. This industry type is permitted only in the Heavy Industrial (HI) zone.

Per conversation with the applicant, manufacturing of ABS/PVC products and magnet assemblies for subwoofers and associated warehousing will be the primary use of the property. Full evaluation of proposed uses on the site would take place during the development review and business license process. Full review of compliance with minimum development standards would be completed at time of site plan submittal. Staff notes that a 100 ft. setback from S. Guignard Pkwy. will be required if this request is successful, as S. Guignard Pkwy. is an arterial roadway.

Environmental

The property is not located in regulated Special Flood Hazard Area (SFHA) per FEMA Firm Panel: 45085C0313E with an effective date of October 27, 2022.

The site is in close proximity to a blue line stream as shown on USGS topographic maps, and predominately within areas identified to be wetlands per National Wetland Inventory (NWI) data available through the US Fish and Wildlife Service. The NWI is used to identify likely locations of wetland areas, the actual delineation of wetlands boundaries must be performed by a qualified professional. The jurisdictional status of any such wetlands must be determined by the US Army Corps of Engineers.

The topography of the site features a southwest downhill slope from S. Guignard Pkwy to rear of the property. The change of grade is approximately 8 ft.


Infrastructure

The site can be served by public water provided through the City of Sumter. Sewer is currently unavailable to the site but is located in close proximity. Sewer service provision would require an extension of main lines and potentially the installation of a lift system. These improvements must be coordinated with the City of Sumter Public Services Department, with improvement cost borne by the developer. If sewer is unable to be provided to the property, a private septic system would have to be installed.

III. COMPATIBILITY WITH THE 2040 COMPREHENSIVE PLAN

As shown in the 2040 Land Use Map, the property is located within the Suburban Development planning area and is influenced by the Priority Commercial Corridor designation.

The primary goal of the Suburban Development planning area is to scrutinize and manage existing development patterns, identify appropriate locations for new commercial and industrial development, to focus on improvements to the form and design of new development, and to ensure that land is developed in an orderly and efficient manner.



The Priority Commercial Corridor designation is an overlay. Areas with this designation have been host to a diversity of uses from large, destination retail uses to more base industrial outdoor storage uses.

The goal of all identified Priority Investment Areas is to identify, direct, and concentrate new development opportunities more acutely. As outlined previously in this report, the majority of the property is within areas identified as wetlands per National Wetland Inventory (NWI). While the NWI is not a substitute for a wetland delineation, given the potential that there are wetlands on the site, the following Green Infrastructure Element Policies are apt:

- Where logical, green infrastructure features should be left in their natural state, untouched, except for passive recreation uses such as trails.
- All land development projects shall protect environmental resources whenever possible through the use of conservation design techniques, the practice of identifying green infrastructure and designing around these resources.

Commercial zoning would be in line with the policies for Priority Commercial Corridor areas, as such designations typically apply to older primarily commercial areas along arterial roadways. The segment of S. Guignard Pkwy that the property fronts was widened to 5 lanes in the mid-2000s to provide better transportation connections and promote industrial growth in nearby areas.

However, the site is also located within the broader Suburban Development area where the goal is to scrutinize and manage existing development patterns and to identify appropriate locations for new commercial and industrial development. Existing land uses close to the subject property consists of single-family residential houses on larger lots, vacant land, and religious institutional uses. There are industrial uses located on the opposite side of S. Guignard Pkwy. to the northwest of the property that are setback several hundred feet from the road. Allowing industrial uses on the subject property given its limited size, proximity to established residences, and geographic constraints may be inappropriate at this time considering the context.

IV. TRANSPORTATION REVIEW

The location of the proposed rezoning is 1650 S. Guignard Parkway (US-521 South). The site's primary road frontage is on US-521, which is an SCDOT-owned and maintained road. In the area of the site, US-521 is a 5-lane highway functionally classified as a Major Arterial Road. The 2024 annual average daily traffic (AADT) volume for US-521 was 8,300, based on SCDOT count station #138.

The site also fronts an undeveloped private drive, or "paper street" known as Jimmie St. Jimmie St. serves as a de facto driveway access for 3 developed residential lots as well as potential access for 4 additional undeveloped lots of record.

Any proposed development at the subject property will have its transportation impacts evaluated at time of site plan approval with appropriate mitigation measures required.

V. STAFF RECOMMENDATION

Staff recommends <u>denial</u> of this request to rezone +/- 2.2 acres of property from Agricultural Conservation (AC) to Heavy Industrial (HI). While the property is within a Priority Commercial Corridor area within the Suburban Development context, the characteristics of this particular property do not lend themselves to industrial use at this time. Establishment of a zoning district on the property that allows industrial, and warehouse uses, has the potential to disrupt adjacent less intensive land uses, including established residences. Available information and data suggests that the site contains environmental features that Sumter 2040 policies seek to protect. Due to these factors and given the site's dimensions, development of the site for industrial use is likely to be challenging in general.

Staff's recommended course of action concerning this request is to either make no change to the zoning designation of this property or to consider a less intensive commercial zoning district, such as Neighborhood Commercial (NC), where the intent is to meet the commercial and service needs generated by nearby development.

VI. DRAFT MOTION

- 1) I move that the Planning Commission recommend <u>denial</u> of RZ-25-17, rezoning two parcels (TMS #225-00-03-010; 225-00-03-035) totaling +/- 2.2 acres from Agricultural Conservation (AC) to Heavy Industrial (HI).
- 2) I move that the Planning Commission recommend <u>approval</u> of RZ-25-17, rezoning two parcels (TMS #225-00-03-010; #225-00-03-035) totaling +/- 2.2 acres from Agricultural Conservation (AC) to Heavy Industrial (HI).
- 3) I move an alternate motion.

VII. PLANNING COMMISSION – September 24, 2025

The Sumter City – County Planning Commission at its meeting on Wednesday, September 24, 2025, voted unanimously to defer the request to rezone a +/- 2.2-acres of land from Agricultural Conservation (AC) to Heavy Industrial (HI). The property is located at 1650 S. Guignard Pkwy and represented by TMS#'s 225-00-03-010 and 225-00-03-035.
